Please read this document carefully before you work on your proposal or fill in the application form. It will tell you who can apply, what you can apply for, and what your application must include.

If you have any questions that this document does not answer, or if you need advice on your application or the activity you are applying for, you may contact us before you apply. Please read the application materials and be ready to describe your activity to us. This will save time and help us give you good advice.

Grant Schedule

This schedule outlines when Grants open (Call for Proposals), Application Deadlines, and when the decisions are made and the grants are issued should they be successful.

Please note that there will only be ONE awardee per grant in all categories.

Creative Worker Category Definitions

Grant calls are now standardized in terms of category definitions and criteria for selection. Grants are offered, recognizing the standard definitions adopted across the CNCF of categories of creative workers.

Nascent: Pre-Professional individuals practicing for less than one year.

Emerging: Practicing for one to two years, may have earned a tertiary certification and/or high school award, and demonstrates potential through submission of a portfolio of work.

Established: practicing for three to seven years with a history of completion of projects, awards, revenue, and preferably a registered business.

Export-ready: practicing for more than eight years with a registered business, a history of staffing (part-time and full-time), and key business structures in place, including accounts, a business plan, administration, compliance, and a communications structure.

Alumni: Given the funding history of the grant program and the longevity of the foundation's work with artists, grant alumni have been added as a category.

Please note that there will only be ONE awardee per grant in all categories.

Community Catalyst/Creative Dialogue Grant

And

Interdisciplinary Innovation Grant

These two grant programs focus on connections across the community and across sectors. These grants are designed to strengthen the community of practice in Cayman Islands by strengthening community and regional links and driving economic impact through culture. Art examines cultural practices, helping societies reflect on identity and social values.

The target for this grants cycle is building community and intersectoral links with a focus on cultural or heritage elements unique to Cayman.

Grants Committee

Grants are given through the Grants Committee and may include non-voting representatives from the CNCF.

Community Catalyst/ Creative Dialogue Grant

Purpose

To support individuals or collectives in networking and knowledge sharing. This grant aims to animate the Community of Practice through curating knowledge-sharing spaces, facilitating peer learning, building infrastructure for collaboration and/or hosting regional and international practitioners. The grantee will propose and execute a project that meets an established need within the community and focus on learning exchange and collaboration.

Scope

The Community Catalyst Grant is designed to provide support for the development and presentation of a collaborative work by an *established or export ready* artist. This can include but is not limited to providing workshops, meet-ups, digital forums, lectures and exhibitions. This project also may support a national institution or project. The recipient is awarded \$10,000 in direct funding to complete the proposed project. In addition, this grant includes the use of the Mind's Eye Centre without additional cost for and staffing the centre during the program; ensuring that creative workers have access to professional facilities without incurring venue costs. The grantee's biography and their project will be featured across CNCF media platforms to help support visibility for the work and the creative professionals involved. This grant represents an investment in knowledge sharing and talent development in the Cayman Islands

- Use of the Mind's Eye Centre for the project showcase where appropriate
- Staffing of the mind's Eye Centre for ongoing projects such as exhibitions
- Grantee biography featured on CNCF media
- Grantee production featured on CNCF media

Interdisciplinary Innovation Grant

Purpose

To encourage cross-sector collaboration between artists and professionals in other fields (example: science, agriculture, education, technology, environment, tourism), especially as aligned with notable community needs. The interdisciplinary grant builds meaningful connections across disciplines in order to reinforce the foundational nature of culture throughout all systems. This grant empowers residents to analyze or create works that enrich both cultural life and everyday well-being.

Scope

The Interdisciplinary Innovation Grant is designed to provide support for the development and presentation of a work by *any category* of creative worker. Examples of cross collaborations include but are not limited to: foodway traditions and tourism, visual arts and environment, dance and wellness. The recipient is awarded \$5,000 in direct funding to complete the proposed project. In addition, this grant includes the use of the Mind's Eye Centre if needed for meetings, exhibitions, workshops etc. without additional costs for venue and staffing. Creative workers therefore have access to professional facilities without incurring venue costs. The grantee's biography and their project will be featured across CNCF media platforms to help support visibility for the work and the creative professionals involved. This grant represents an investment in resource sharing, innovation and sustainability in the Cayman Islands

- \$5,000
- Use of the Mind's Eye Centre for meetings, workshops, etc
- Staffing of the mind's Eye Centre for above
- Grantee biography featured on CNCF media
- Grantee production featured on CNCF media

Making Your Application Eligible to be Assessed

We cannot assess applications that are not eligible. You can do the following things to help avoid this:

- Read through the application guidelines carefully.
- Allow enough time for us to reach our decision and for you to start planning and preparing to start your activity. If your activity/project is solely dependent on CNCF funding, we would recommend you not start the activity/project until a decision has been made by the GFA Committee. Fill in the application form completely.
- Attach a detailed budget showing projected sources and amounts of income, as well as a breakdown of projected expenses related to the activity, giving us as much information as possible so we can see how you have reached your figures. If your budget exceeds the Grant allowance, please include your other confirmed or expected funding sources, which can include funding from other public entities, private sector donations, and personal funds.
- Make sure your budget balances. The total income should be the same as the total spending.
- Review the checklist and ensure all the required documentation is available for your application
- If you're applying on behalf of a group, provide the names and contact information for two people who are authorised to sign cheques on behalf of the group.
- Use the artist categories and send in supporting documents to support your application.

Not every eligible application is successful. Applicants are encouraged to consider other options if CNCF cannot fund their activity.

Eligibility

At this time, eligibility is limited to individuals who are resident in the Cayman Islands and have been resident in the Cayman Islands for the preceding twelve (12) months and operate in the Cayman Islands.

Grants are for activities carried out over a set time period. Grantees must be able to complete the activity within the specified time frame.

Grants applicants must register with the CNCF National Artists' Registry when it is available.

Prospective applicants must carefully check the specific eligibility requirements for each grant type, if present.

Who qualifies:

- Practitioners in the fields: of the visual arts (including craft and design), the performing arts (theatre, music, dance and other performance forms), the literary arts (prose and poetry, fiction and non-fiction, and spoken word) and film (fiction and documentary, feature-length and short, animation); other cultural practitioners (for instance, the culinary arts, ethnobotanists), cultural researchers, organizers and educators, preservationists and other creative workers.
- Individuals and groups can apply for grants. Groups can be established groups, but also more informal groups constituted for a collaborative project. It is the responsibility of the applying group to ensure that there are clear arrangements regarding the leadership of the project and the receipt and handling of the funds, a matter that will be considered in the selection process. A spokesperson should be appointed who will serve as the primary point of contact for CNCF.
- Creatives legally resident in the CI (Caymanian and non-Caymanian)
- Creatives who have proven competence in their area of application.

- The grants are designated primarily for adult applicants (over 18 years old), but groups can include minors, with appropriate adult supervision, parental permissions, and any necessary safeguarding frameworks. Exceptionally, individual minors may be considered for grant support, provided parental permission, supervision, and responsibility of funds, and necessary safeguarding frameworks are in place.
- The activity must take place mainly in the Cayman Islands. There are some exceptions to this when artists or arts groups from the Cayman Islands are involved in activities in other countries. There are some exceptions to this when individuals or groups are showcasing on an international stage.

Eligibility Notes

- Arts groups that can share out profits to members or shareholders (businesses) will not be considered for grants, unless the activity that is applied for is a self-contained arts project and has a clear benefit to the public
- Individuals or arts groups based (living) outside of the Cayman Islands will not be considered for grants.
- Groups must have a bank account with two people who can sign in the group's name.

You cannot apply for the following activities:

- Activities that are not related to the arts/culture and heritage
- Activities that provide no potential benefit to the public, either in the short or long term
- Activities, including buying goods or services, which take place or start before we can decide about your application
- Activities, equipment, or events that duplicate what already exists
- Costs that are already covered by other funding
- General running costs and overheads that are already paid for by other income, including your own funds
- Ongoing overheads relating to equipment or buildings, such as insurance and maintenance costs

- Fundraising events, such as charity galas, that do not benefit the arts
- Activities or events that mainly take place outside the Cayman Islands. There are some exceptions to this, for example, grants for international travel or training, and international exchanges, but these activities must benefit individuals and artists living in, or arts groups based in, the Cayman Islands
- Activities that do not benefit or engage people in the Cayman Islands or that do not help artists and arts groups in the Cayman Islands to carry out their work
- Buying equipment and instruments which would not be used for the benefit of the public, either immediately or in the long term, or where the applicant does not have an artistic track record
- Self-promotional activities which do not provide public benefit, either immediately or in the long term, or where the applicant does not have an artistic track record
- Activities in a formal educational setting for educational purposes are necessary by law
- Afterschool programmes

How We Assess Your Application

Criteria for Grants Evaluation

Criteria and weighted measures are built for each Grant. These criteria include a description and a weighting/score within the scoring matrix. The criteria are published in advance along with the call for proposals. You should ensure your project will score highly for the highest weighted criteria.

Criteria include:

- Social and environmental impact, including advocacy & analysis
- Creativity, innovation, and process
- Documentation methods
- Heritage and technology: including digitisation & preservation
- Relationship between artistic forms
- Collaboration with other partners, mentorship and apprenticeship, local and international
- Gender, Youth, and Wellness
- Audience Development
- Creation of new spaces/ Enlivening community spaces
- IP and Bridging the Gap: Integration across industries
- Mentorship/Apprenticeship
- Exchange/Movement
- Status of the Artist
- Innovation/Sustainability

Criteria also include some administrative considerations and considerations regarding project feasibility:

- Project organization and design
- Applicant experience/expertise/qualifications
- Access to goods and services
- Access to technology and spaces
- Budget clarity, transparency, and feasibility
- Alignment with grants' thematic progression

Criteria are weighed according to the Grant and the focus for the year. Scores are applied, and the total score is considered for each grant. Theatre Grant criteria is as below:

Grant Application Requirements Checklist

Ensure that you review the checklist thoroughly and have all the necessary elements before applying.

Registration Information:

- Full name / Organization name
- Contact details (address, phone, email)
- Legal status (individual, nonprofit, company, institution)
- Eligibility Confirmation: Artist Category, Caymanian, Age
- Statement confirming compliance with eligibility criteria

Proposal Application Information:

- Project Title and Summary
- Abstract (150–250 words) outlining purpose, goals, and expected outcomes
- Project Description
- Background and rationale; supporting data sets where possible
- Objectives and intended impact
- Target audience or beneficiaries
- Alignment with Grant Purpose
- Explanation of how the project addresses community needs
- Timeline and Work Plan
- Key milestones
- Start and end dates
- Deliverables schedule
- Budget and Financial Information
- Detailed budget breakdown (personnel, materials, overhead)
- Other funding sources or co-funding commitments
- Sustainability plan beyond the grant period/next steps
- Anticipated short- and long-term outcomes
- Evaluation and Impact Measures
- List of partners or collaborators

Additional Submissions (Supporting Documents):

- CVs or bios of key personnel
- Samples of previous work or publications
- References or endorsements needed for some grants
- Intellectual property, copyright, and Creative Commons considerations
- Ethical considerations where necessary
- Safeguarding documentation where necessary
- Submission Checklist
- Confirmation that all required sections and attachments are complete
- Applicant signature and date

FAQs

What Happens if You are Offered a Grant?

You will receive a letter of acceptance followed by a contract outlining all requirements and terms and conditions of accepting the grant.

These documents are provided by the grants secretary upon the success of your grant application. We may add special conditions to our offer of a grant. This is perfectly normal, and most grants will have some extra conditions attached.

If you receive a grant offer but no longer want to accept it, please let us know in writing. You must accept the offer within TWO weeks of notification. This means signing the contract and returning it to us. We will make all payments when you have met any conditions associated with receiving payment. If you applied as a group of people, you will need to send the bank details, including the names and contact information of two people who are authorised to sign cheques on behalf of the group. The person taking the lead in making the application will be responsible for the grant. You must also continue to meet our standard grant conditions.

What Happens if Your Application is Unsuccessful?

You will receive a letter outlining the main reasons why your application was unsuccessful. You can apply again in the next grant cycle. We will not be able to assess repeat applications for the same activity/project that have not addressed the concerns expressed in the first (unsuccessful) application.

Complaints

Any artist/group who has submitted an application for a grant and has reason to believe that the application was unfairly dealt with is encouraged to submit a written complaint in the form of an email to the Secretary of the CNCF Grants Committee at grants@artscayman.org. The complaint should be made within five (5) working days of receiving notification of an unsuccessful application. A response will be provided via email within 10 working days after CNCF receives the complaint.

Important Note

Please note that once you press the submit button for your application, you have consented to your data being collected. All registration data collected will be stored on our database and used in compliance with data protection laws in the Cayman Islands.

Your Work and the Freedom of Information Act

The Cayman National Cultural Foundation is committed to being as open as possible. This includes being clear with you about how we assess and make decisions on Grants for the Arts. If you apply to us for a grant, we are happy to give you copies of the information we hold about you, including our assessment of your application.

We are also listed as a public authority under the Freedom of Information (FOI) Act 2007. By law, we may have to provide your application documents and information about our assessment to any member of the public who asks for them under the Freedom of Information Act 2007. However, we will not release those parts of the documents covered by one or more of the exemptions under the Act. Visit the website at www.ombudsman.ky for information on the exemptions and freedom of information generally.

This section describes how we generally plan to treat your application documents and assessment information if someone asks to see them under the Freedom of Information Act 2007. However, it does not cover all cases as we have to consider each request for information individually, based on the situation at the time.

We do not release any information about applications during the assessment as this may interfere with the process. After we have assessed your application, we may release your application documents and information about our assessment if a member of the public asks for them. Here are details of what information we would not release.

Whether your application was successful or not, in processing or the event has already happened, we will not release the following:

- Your name, home address, email address, phone, cell phone, and fax numbers, and any details of your background (if you have any details provided)

- Any information you said was confidential when you applied to us for funding. This can include your written proposal, financial information such as your budget or business plans,

Under the Freedom of Information Act 2007, if we are asked for information after your activity has ended, we will generally release your proposal and budget, together with all other information in your application documents permitted by data protection laws of the Cayman Islands. We will not do this if you provide good reasons for the information to remain confidential after the end date in the application form.
